# Algebris Investments (UK) LLP launches Long Only Financial Credit UCITS

Algebris Investments (UK) LLP, headed by Davide Serra, is a boutique asset manager specialised in financials, with assets of \$1.1 billion and manages both hedge funds and long only funds in equity and credit.

The Algebris Financial Credit Fund is an actively managed, long only, corporate credit fund focused on financial credit globally. The Fund seeks to achieve a high level of income and modest capital appreciation by investing in debt and hybrid capital instruments issued by banks and insurance companies.

Specifically, the Fund invests in the financial sector globally, primarily in debt securities with fixed and variable coupons, which may be rated investment grade or below investment grade. Currency exposure will be systematically hedged. The Fund may also invest in other financial instruments, including convertible securities (bonds that can be converted into shares), hybrid securities (instruments that combine some of the characteristics of bonds and shares), preference shares, subordinated debt and deposits.

Davide Serra, Founding and Managing Partner of Algebris Investments commented: "The Algebris Financial Credit UCITS Fund was launched to give onshore long only investors across Europe access to our financial credit expertise and sector focus. We have been managing credit strategies since 2009 and have significantly outperformed the benchmarks. We believe there are very interesting opportunities in this space as the regulation changes brought on by Basel III are rolled out".
