Sir Jon Cunliffe Biography

Sir Jon Cunliffe was the Deputy Governor of the Bank of England with responsibility for Financial Stability from 2013 to 2023 and sat on the Bank's Court of Directors, the Financial Policy Committee, the Monetary Policy Committee and the Board of the Prudential Regulation Authority.

Before joining the Bank, Jon was the UK Permanent Representative to the European Union, effective from January 2012. From July 2007 to December 2011, he was the Prime Minister's Advisor on Europe and Global Issues and the UK Sherpa for the G8 and G20 and the Cabinet Office Permanent Secretary responsible for EU coordination. Between 2002 and 2007, Jon was Second Permanent Secretary at HM Treasury, Managing Director of the Macroeconomic and International Finance Directorate.

Jon was appointed a Companion of the Order of the Bath in the New Year Honours 2001, and made a Knight Bachelor in the New Year Honours 2010.
